

### AN ORDINANCE

ACCEPTING BID AND AUTHORIZING CONTRACT with.....

*Delta Concrete Company*

for Street Improvements on..... *Beekman Place* ..... Street  
and Appropriating Money therefor.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

WHEREAS, in sufficient compliance with the provisions of the existing "Procedure Ordinance" of this City, this City Council has ordered the improvement of.....

*Beekman Place*

from..... *Peasey Place* ..... Street

to..... *King Highway* ..... Street

by the construction thereon of permanent paving and other work of the following general character

*limited paving trap rock surface curbing etc all as specified with guarantee*

and has received and considered bids for constructing and effecting said work, among which was the bid hereinafter accepted, which said bid is deemed by the City Council to be the best bid and the proposal and contract most advantageous to the City and to the owners of property on said highway; and

WHEREAS, the specifications, plans, profiles and drawings for said work and improvements were duly prepared and filed by the City Engineer, being the same upon which said bids were based, and the same have been heretofore and are hereby duly approved and ordered to be made a part of the contract for said work and improvements; and

WHEREAS, the contract and bonds for the construction of said work and the guaranty and maintenance thereof, have been prepared by the City Attorney and have been submitted to and examined by this City Council; and

WHEREAS, the City Council now desires to accept said bid and to cause the due execution of said contract and bonds, and to appropriate money for payment of the City's part of the cost of said work, which part has been estimated by the City Engineer at the sum of.....

*seventeen thousand nine hundred (\$17,900)* ..... Dollars;

Now Therefore Be It Further Ordained:

FIRST. That the bid or proposal of.....

*Delta Concrete Company*

for constructing and completing said work and improvements, in accordance with said specifications, plans, profiles and drawings, and under the "Procedure Ordinance" of this City, be and the

same is hereby accepted, and said proposal together with said specifications, plans, profiles and drawings are all hereby made a part hereof.

SECOND. That said contract and bonds be and the same are hereby approved as to form; and that the Mayor be and he is hereby authorized and directed to proceed with and require the due execution of said contract and bonds, and to cause the due conduct of all other and further business and proceedings in connection with said matters in compliance with and subject in all respects to the provisions of said "Procedure Ordinance."

THIRD. That for the purpose of defraying those portions of the cost of said improvements which are to be paid by the City under the terms and provisions of said contract and said procedure ordinance, the sum of.....

*Forty thousand nine hundred (\$49,000)* Dollars,

or so much thereof as may be necessary, shall be, and the same is, hereby appropriated and set aside out of the SPECIAL PAVING FUND of this City derived from the sale of the bonds of the City dated September 1st, 1913, and said sum so set apart and appropriated is hereby made a special fund to be known and denominated as "Special Fund No.....

*Deerpark Place*

Street Paving Contract," and the same shall be pledged, kept and expended solely for the purpose of paying the City's part of the cost of said work in accordance with said contract, and shall not be appropriated or drawn on for any other purpose whatever.

FOURTH. That this ordinance, being passed under suspension of the rules, shall take effect from and after its passage and approval.
